- 1. Please affix Passport size Colour Photograph same as that was attached in your application form in the space provided on the upper portion of the E-Call letter.
- 2. E-Call letter is valid only with Original & Photo copy of any one of the following IDs: **Employee ID (Mandatory)** Driving License, Passport, Voter ID, PAN Card, Aadhar Card UID.
- 3. Candidates must also bring two colour photographs (of size 3.5 cm x 3.5 cm) and also a post card size photograph with clear front view of the candidate without cap and sunglasses, for appearing in the ONLINE examination.
- 4. This E-Call letter is valid only for the test date and session time as specified on the E-Call letter.
- 5. Candidates should report at 10:30 hrs.
- 6. No candidate will be allowed inside the test centre after 11:30 hrs.
- 7. A candidate should write the Self-Declaration inside the exam lab in the presence of the Invigilator.
- 8. Mobile phones or any other electronic gadgets such as watches, calculators are NOT ALLOWED inside the Test Centre. There is no facility for safe-keeping of your personal belongings outside the examination hall and RRC-ER/Assessment service provider is not responsible for its loss. Only E-Call letter, Photo ID card, pen/pencil will be allowed inside the test hall.
- 9. The candidate can view and answer questions in any of the 2 languages applicable.
- 10. There will be negative mark for wrong answers. For every wrong answer 1/3rd mark will be deducted.
- 11. Friends and relatives accompanying the candidate will not be allowed inside the test centre.

- 12. Rough sheet(s) will be provided to the candidate for rough work, which will have to be returned after the test.
- 13. Candidate should write his/her name and registration number on the rough sheet(s).
